## RENEW PERSPECTIVES, LICENSED CLINICAL SOCIAL WORKER, P.C. TERMS OF USE & PRIVACY POLICY

## PRIVACY POLICY

This Privacy Policy addresses the practices of Renew Perspectives regarding information collected from users of Renew Perspectives's website (or "the Site") located at <a href="http://renewperspectives.org">http://renewperspectives.org</a>, and only addresses information collected directly through or from the Site. This Privacy Policy does not address or govern any information gathering, use, or dissemination practices related to information collected from the user (sometimes referred to as "you" or "your") through non-Site-related means such as from telephone, facsimile, postal mail, personal delivery, email, social media or other or additional means or media.

- 1. Collection of Personal Information from Users. Except as specifically set forth herein, Renew Perspectives may collect or track: (a) the email addresses of users; (b) information knowingly provided by the user in online forms, registration or membership forms, surveys, email, and other online avenues (including, without limitation, demographic and personal profile data); (c) financial information and other information provided by a user to purchase Renew Perspective products; (d) information related to the provision of counseling services; (e) aggregate and user-specific information regarding pages accessed by a user; (f) the home server domain names, date and time of your visit, type of computer, the originating IP address, files downloaded, search engine used, operating system, and type of Web browser of users of the Site; and (g) for users who opt-in to the Geolocation service (described in greater detail in Section 7 below), the location of users of the Site. Renew Perspectives may place Internet "cookies" on your hard drive. Internet cookies are small amounts of data that contain a unique identifier that many websites frequently send to your web browser to save data about you, such as your name, password, user-name, screen preferences, and the pages of a website you have viewed. When you revisit the Site, Renew Perspectives may recognize you by your Internet cookies and customize your experience accordingly. You may decline Internet cookies by using the appropriate feature of your Web browser software, if available. Renew Perspectives may use Google Analytics or a similar service to gather, store, and track certain information related to your visit to and activity on the Site.
- 2. **Use of Personal Information Collected**. Personal information collected by Renew Perspectives may be used by Renew Perspectives for many reasons, such as: providing products and services to customers; contacting users regarding registration and account status; providing certificates of training completion; provision of counseling services; updates to Site Terms; billing; recordkeeping, editorial and feedback purposes, marketing and promotional purposes, statistical analysis of users' behavior, product development, content improvement, or to customize the content and layout of the Site.
- 3. **Disclosure of Personal Information to Third Parties.** Except as outlined herein, individually identifying personal information provided through the Site will not be sold or otherwise disclosed to third parties not affiliated with Renew Perspectives without the prior consent of the user.   - To our third-party service providers who provide services such as website hosting, data analysis, payment processing, order fulfillment, infrastructure provision, IT services, legal services, customer service, email delivery services, credit card processing, auditing services and other similar services to enable them to provide services. Renew Perspectives is not responsible for, and will not be liable for, the conduct, actions, omissions, or dissemination practices of third parties.

- To insurance companies to seek reimbursement for services provided.
- When you post information on message boards, chat, profile pages and blogs and other services
  to which you are able to post information and materials. Please note that any information and
  materials that you post or disclose through these services will become public information, and
  may be available to visitors to the Site and to the general public. We urge you to be very careful
  when deciding to disclose your Personal Information, or any other information, on the Site.
- To a third party in the event of any reorganization, merger, sale, joint venture, assignment, transfer or other disposition of all or any portion of our organization or assets (including in connection with any bankruptcy or similar proceedings).
- If determined by Renew Perspectives in its sole judgment that such disclosure or distribution is appropriate to protect the life, health, or property of Renew Perspectives or any other person or entity.
- As we believe to be necessary or appropriate: (a) under applicable law; (b) pursuant to a subpoena, court order, warrant or other form of legal process; (c) to respond to requests from public and government authorities; (d) to enforce our terms and conditions; (e) to protect our operations; (f) to protect our rights, privacy, safety or property; and (g) to allow us to pursue available remedies or limit the damages that we may sustain.
- 4. **Online Payments**. Online payments are processed through secure servers operated by GoToTraining PayPal and PayEezy ("Payment Processors"), third-party vendors not owned by or affiliated with Renew Perspectives. Information provided by a user will be accessible to a Payment Processor to complete the transaction and retained pursuant to each Payment Processor's Terms & Conditions.
- 5. **Third Party Websites.** The Site may contain links to third party internet websites for the convenience of users in locating information, products, or services that may be of interest. If you access a third-party website from a link on this Site, any information you disclose on that website is not subject to this Privacy Policy. It is possible that any link you access may be used by third parties or others to collect personal or other information about you. Renew Perspectives does not control and is not responsible for the content or privacy practices of third party websites, their use of cookies, collection of information, or how they manage such information. It is solely your obligation to review and understand the privacy practices and policies of these other websites, advertisers and any third parties.
- 6. **Internet and Data Security.** Renew Perspectives uses high-grade encryption and security protocols (Secure Socket Layer-SSL) with respect to all confidential and personal information including when processing financial transactions. This method is the industry standard security protocol, which makes it difficult for anyone to intercept the information you send us. Renew Perspectives also stores data internally on password-protected servers. Our staff is trained in the importance of safeguarding your information and only those who need the information to perform a specific job (for example, billing or customer service) are granted access to personally identifiable information. In addition, all electronic protected health information (ePHI) is maintained in a manner that is compliant with the Health Insurance Portability and Accountability Act (HIPAA). However, such precautions do not guarantee that the Site is invulnerable to all security breaches. Renew Perspectives makes no warranty, guarantee or representation that the use of its Site is protected from all viruses, security threats or other vulnerabilities and that user information will always be secure.
